Work through these after trying the questions yourself.

4.6 People who want a job but cannot find one.

4.7 The economy makes less (lost output), and the unemployed have less income (any one).

4.8 A general rise in prices over time.

4.9 Money buys less than before —its value falls.

4.10 5%.

4.11 The worker is **worse off**. Prices rose by **5%** but the wage rose by only **3%**, so the wage buys *less* than before —their **real income has fallen**.
